1. Be younger than 21 for the entire term of office (Sept 1, 2019 through Aug 31, 2020)
2. Be registered in Scouting in the Westark Area Council
3. Be a member in good standing in the lodge (dues paid)
4. Attend **ALL** scheduled Lodge events and the SR-8 Conclave. See Attached list.
5. Communicate regularly with your adviser and other officers/chairmen throughout the year.
6. Create goals, milestones, budget, and calendar for your elected position in consultation with your adviser.
7. Meet the goals and milestones that you set.
8. Recruit, train, and lead lodge members in carrying out the lodge's year-round program.
9. Set the example by correctly wearing a full Class A uniform.
10. Always conduct yourself according to the highest standards of the Scout Oath, Law, and OA Obligation.

The success of a Lodge is dependent on active, engaged officers. Each officer will have an experienced adult adviser assigned to him to coach, guide and assist him in the execution of his duties. Lodge officers are expected to effectively budget their time and diligently work with their adviser, fellow officers, chairs, and other Arrowmen.
